On Tax Levy in Excess of the Ten Mill Limitation

Notice is hereby given that in pursuance of a Resolution of the Allen East Local School District of Allen County, Ohio, passed on the 17th day of February, 2009 there will be submitted to a vote of the people of said subdivision at a Primary Election to be held in the Allen East Local School District of Allen County, Ohio, at the regular places of voting therein, on the 5th day of May, 2009, with the issue:

A renewal of a tax for the benefit of Allen East Local School District for the purpose of **RENOVATING, REMODELING AND IMPROVING SITES AND FACILITIES AND PURCHASING EQUIPMENT AND SCHOOL BUSES FOR SCHOOL PURPOSES** at a rate not exceeding 2.75 mills for each one dollar of valuation, which amounts to \$0.275 for each one hundred dollars of valuation, for a period of 5 years, commencing in 2009, first due in calendar year 2010.

which amounts to \$0.344 for each one hundred dollars of valuation, for a period of 5 years, commencing in 2009, first due in calendar year 2010?

A renewal of a tax for the benefit of Bath Township for the purpose of **PROVIDING AND MAINTAINING FIRE APPARATUS, APPLIANCES, BUILDINGS, OR SITES THEREFORE, OR SOURCES OF WATER SUPPLY AND MATERIALS THEREFORE, OR THE ESTABLISHMENT AND MAINTENANCE OF LINES OF FIRE ALARM TELEGRAPH, OR THE PAYMENT OF PERMANENT, PART-TIME, OR VOLUNTEER FIREFIGHTERS OR FIREFIGHTING COMPANIES TO OPERATE THE SAME, INCLUDING THE PAYMENT OF THE FIREFIGHTER EMPLOYERS' CONTRIBUTION REQUIRED UNDER SECTION 742.34 OF THE REVISED CODE, OR THE PURCHASE OF AMBULANCE EQUIPMENT, OR THE PROVISION OF AMBULANCE, PARAMEDIC, OR OTHER EMERGENCY MEDICAL SERVICES OPERATED BY A FIRE DEPARTMENT OR FIREFIGHTING COMPANY**, at a rate not exceeding 3 mills for each one dollar of valuation, which amounts to \$0.30 for each one hundred dollars of valuation, for 5 years, commencing in 2009, first due in calendar year 2010.
